The following resolutions were made unanimously:

Resolution No.01

Resolution No-01 dt. 20.06.18, then the Principal is authorised to file writ petition in the Hon'ble High Court, Odisha against the order.

#### Resolution No-04

#### Resolution No-05

The G.B. reviewed the salary enhancement of MP staff and unanimously resolved that increment @ 3% cannot be interpreted as annual increment and accordingly the said increment cannot be applicable to subsequent years.

#### Resolution-06

Being convinced by the report, the G.B. authorised the Principal to go through the Act by which Sri Sahu was suspended and apprise the G.B. in the next meeting for reinstating him.

The G.B. approved the creation of the post of Additional Accounts Bursar and enhanced the remuneration of the Accounts and Additional Accounts Bursar to Rs 1000/- each w.e.f. 01.08.18.


Resolution No. 8
