Discussions were made on the agendas and the following resolutions were taken unanimously.

Agenda-01 - Resolved that the college would deposit the EPF contribution of the management staffs appointed and regularised after 2014. As the EPF contributions to employees under statutory provision of the Government are mandatory for the principal to deposit the amount required.

Agenda-02 - Resolved to keep the case of Smt. Nirupama Panda, Lect. in Botany in abeyance as her case is under subsudice vide G.B. resolution No. 02 dt. 20-6-2018 (counter affidavit receipt No 28595 of 2018). The principal is requested to file the counter Affidavit against the affidavit filed by Smt. N. Panda vide WAC No 16510 of 2016.

Agenda-03 - Discussions were made on the exigency of the office and on the requirement of the office staffs. The President urged to know the individual work assignment of all five staffs.

(03 D.P and 02 Mr. Staffs) for the justification of the requirement sought for the extension of contractual Staff members. Resolved to extend the services of Sri K. Mohapatra (P.E.T), A. The President asked the Principal to work out the workloads of these persons and to produce Chat on the next G.S. Meeting.

Agenda-04 - Regarding the extension of services of the teaching Staffs, it was resolved that Smt. J. Bhoi, Lect. in Economics would continue in her post as more faculty would be required in Economics in the coming days. However, it was resolved to retrench Miss Subhansubala Tripathy, Lect. in Education as her extension has been exhausted and the management has decided to recruit Lectures through fresh advertisement as and when required.

Agenda-05. Regarding the Government assistance of Rs. 10 lakhs received by the college for renovation and repairing works of the college building, the President expressed his deep concern and immediately called on the Municipality Engineer to expedite the plans and estimates of the works to be completed in time.

Agenda-06 - Emphasizing the academic parts of the institution, the President requested the Principal to give instructions to teachers to take extra classes for revision of courses after completion of courses assigned to each teacher.
