The following resolutions were made unanimously:

Resolution No. 1

The G.B. discussed the transfer and joining of Dr P.L. Sena, Ex-Reader in Chemistry and Principal I/c of this College who had been transferred to J.N.C College Patnagesh on administrative ground vide DHECO letter No-30179 dt. 19.08.2017 consequent upon the letter of the Sub-Collector and President, G.B. Sonapur College, Sonapur vide his letter No-3895 dt. 18.08.2017. The G.B. expressed grave concern on her transfer again to this college vide DHECO letter No-19575 dt. 24.05.2018 despite mounting allegations against her from the District Administration, Students, Ambedkar Dalit Kalyan Sangha and Alumni Association etc. Further, Dr Sena filed a writ petition in

The Hon'ble High Court, Orissa vide W.P.C. No. 9653 of 2018 for allowing her to function as Principal i/c of Sonapur College, Sonapur without ^{waiting} for the G.B. approval of her joining. Pursuant to writ petition, she appealed to the President on dt. 25.05.18 to allow her to function as the Principal i/c and the President had referred the matter to the ~~G.B.~~ G.B. for final decision. On this score, the G.B. treated the act of Dr Sena as sheer disobedience to the authority of the Governing Body and unanimously resolved to disapprove her joining report submitted in the office of the Principal on dt. 25.05.2018. The President, G.B. is requested to communicate the resolution to the Secretary, Higher Education and Director, Higher Education for immediate cancellation of her transfer order No. 19575 dt. 24.05.18 for the greater interest of the institution. Further, the President, G.B. is requested to intimate the same to Dr P.L. Sena for information.

Resolution No-02

On the issue of Smt. N. Panda, Lecturer in Botany, the Principal apprised the G.B. that as per Resolution No-02 of the G.B. Meeting on dt. 08.05.18 a counter affidavit has been filed in the Orissa High Court vide receipt No-28595 of 2018 to vacate the interim order of the W.P.C. No. 16510 of 2016 filed by Smt. N. Panda. The G.B. resolved to take further course of action only after the disposal of the petition.

Resolution No.3


On the issue of Sri P. Sahu, the suspended Demonstrator in Chemistry, the G.B. resolved that
