Employees through resolution by circulation was discussed and there was prolonged debate on this issue. Finally, the G.B. resolved that extension of suspension ~~to~~ should be approved by a full-fledged G.B. Meeting and not through resolution by circulation.

2. It was also resolved to look into the legal aspect of the DHE for not approving the suspension order passed by the G.B. and accordingly, authorised the Secretary to do the needful as per O.E. Rule.

As regards the assurance by the District Administration, the Principal-cum-Secretary apprised the G.B. that the District Collector would bear the expenses of digging a deep bore-well ^{in the college campus} shortly after the lifting of code of conduct and simultaneously bear the electricity ~~at~~ dues of the college for the months of April and May 2019 due to occupation of the college buildings by election and police personnel.

5. Subsequently, Dr K. N. Mishra, the Principal-cum-Secretary placed before the G.B. the petition of Sri Ranjan Kumar Mishra, the SSB sponsored lecturer in Logic and Philosophy for enlisting his previous services in different institutions prior to joining Sonapur College. He appealed to the Principal that the new Service Book opened in Sonapur College should make necessary entries regarding his previous service ~~year~~ period for availing retirement benefit in the long run. The G.B. discussed the matter in the light of the Govt. of Odisha Notification enclosed with the petition and unanimously resolved to keep ~~the~~ it in abeyance and authorised the principal to seek instruction from the DHE on this issue.

6. Finally, the G.B. expressed in a spirit of brotherly love that the tension-prone tenure of Dr K. N. Mishra as Principal ^{1/c} from dt-18.08.2017 to dt-30.04.19 would set precedents
