A meeting with the President, Governing Body, Sonepur College, Sonepurrao, Sri Surya Narayan Dash OAS(D) was held in the office of the ADM, Subarnapur at 5 PM on 28-05-2021 and the following resolutions were made

Resolution ① It is resolved to enhance the consolidated amount of Rs. 5000/- for lecturers except the +2 stream, Smt. B. Dehuri, Lect. in IT, Smt. C.K. Biswal, Lect. in Geology and Smt. B. Sahu, Lect. in Statistics which may be considered in future depending on their workload and students strength, Rs. 2500/- for the Librarian, and Rs. 2000 for the Clerical Staff and Rs. 1500 for attendants and peons (of the management staff) respectively w.e.f 1st May 2021 taking into consideration to the following criteria: re-assignment of students strength of the concerned department performance of the employees satisfaction of the authority and commitment.

Resolution ② As per the show cause case No. OR/PP/E CC-1/3575/232 dated 22-12-2020 of the office of the Provident Fund Commissioner (Compliance) EPFO, Bhubaneswar, the Governing Body unanimously resolved to approve to deposit all the EPF and allied dues as per the BCR generated on Dt. 23-04-2021 by EPFO, Bhubaneswar amounting Rs. 12,84,576.00 (Rupees Twelve Lakh Eighty Four thousand five hundred seventy six only) for the period from Jan-1996 to Feb 2008, as it is statutory.

Resolution ③ Further, it is resolved that the payment of EPF for the period from March 2008 to

Feb-2014 work be done after getting BCR from the office of the Regional P.F. Commission, EPFO, Bhubaneswar, depending upon the availability of the funds of the institution.

Resolution no 3 Again it is discussed, whereas 12 (Twelve) no. of employees share of EPF yet to be deposited it may further invoked the penal provision and put the institution under strain. Therefore, before the matter being taken up, it is better to comply the statutory provision and to deposit the admissible amount in EPF account of the concerned employees and any resource which will be generated in future must comply the deductions, which is mandatory under the provision of law. At present also any funds available must be utilized to avoid the future complicity which is unnecessarily drain out the resource of the institution in the shape of interest, which is not at all beneficiary either for the institution or for the employees.


Res. 4. It is resolved that the affiliation amount which is to be deposited as against the continuation of any subject also to be immediately salvaged up by making payment so that ~~no~~ stricture will be received from the affiliating authority which subsequently affect the prospect of the students.


Res. 5. It is resolved that if there is any self financing scheme / subject where students are paying more
